- 5. **OVERTIME.** The Client may request that ZSE continue services longer than the time frame specified in the attached Event Proposal. ZSE will play longer than timeframe specified at an overtime hourly rate of \$100.00 or a rate negotiated between Client and ZSE Staff. Overtime availability is not guaranteed.
- 6. **OUTCOME.** ZSE is not responsible for the outcome of the event, and does not guarantee any certain level of satisfaction or enjoyment by all attendees.
- 7. DAMAGES. The Client accepts full liability for all damages to any equipment in the possession of any ZSE employee that occur as a result of intentional or un-intentional actions, or neglect upon the part of the client or his/her guests, patrons, customers, students, and so forth. If the setup location is outside, Client agrees to provide adequate shelter, to protect equipment from adverse weather conditions.
